HIGHLIGHTS FROM LAST MONTH'S MEETING (NOVEMBER 18)

- The new IHSA guideline for senior gifts is \$150 (raised from \$75). This amount includes senior banners (any items that the athlete keeps count). Regardless of the dollar amount, please do not gift seniors cash or gift cards. The idea is to give them something to remember their time by and to also be mindful of Title IX (making sure there is equity across male and female sports, including with gift giving).

PRESIDENT'S REPORT – Brian Sanders:

- Each group should have their own treasurer and/or director keeping track of their funds. The Main Booster treasurer's bookkeeping should be used as a verification of your bookkeeping, not as a sole means of your bookkeeping.
- Register your fundraisers so Main Boosters can promote them on social media and put them on our fundraising calendar. There are times people question the validity of a fundraiser and it helps for Main Boosters to be aware of what each club is doing.
- <u>INDOOR CONCESSIONS</u>: reminder not to go into the kitchen due to sanitary reasons. Make sure to follow procedures for using the indoor concession area (there is a binder in the area as well as checklists on our booster website). There is a new pizza warmer. Main Boosters is looking into repairing the old pizza warmer.
- Main Boosters received an email from a concerned grandparent feeling there have been too many fundraisers. There is a possibility this is in response to SNAP fundraisers which are typically done by coaches. If any members of your groups have questions regarding fundraisers, Main Boosters can investigate on your behalf if you get inadequate information from your students and/or coaches. Mr. Bral can also be a helpful resource. Encourage your coaches to be transparent about what the fundraisers are for and Booster Directors should also be as transparent as possible in regards to their fundraising purposes. Boosters and coaches should coordinate at the beginning of the season to make sure fundraisers are spaced out and not in conflict.
